Dear Mr. Wood:

On October 5, 2001, the Commission received the payment for the 2000 RAF, plus prior year's penalty and interest charges. Unfortunately, the full amount for the 2000 RAF was not paid. My October 3 letter (2nd paragraph) stated that the RAF is .0015% of a company's revenues OR \$50.00, whichever is greater. Transworld only paid \$39.09 of the minimum \$50.00, leaving a balance of \$10.91 RAF. In addition, the company owes \$12.50 penalty and \$4.50 interest for the late payment of the 2000 RAF for a total past due amount of \$27.91.

The Order is due to be issued by October 22, 2001. As soon as possible after the Order is issued, I will get in touch with you so that the protest/settlement can be filed in this docket. If you need additional information prior to that time, let me know.
