PLEASE TAKE NOTICE THAT on April 27, 2001, (the "Petition Date"), Telscape International, Inc., and its related debtors (collectively, the "Debtors") filed for protection under Chapter 11 of the United States Bankruptcy Code in the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court") and the Debtors' bankruptcy cases have been consolidated under Case No. 01-1563 (JJF).

PLEASE TAKE FURTHER NOTICE THAT, pursuant to Section 362 of the United States Bankruptcy Code, after the Petition Date, no cause of action may be commenced or prosecuted, and no judgment may be taken against any of the Debtors outside of the Bankruptcy Court without the Bankruptcy Court's first issuing an order modifying the automatic stay imposed by Section 362 of the Bankruptcy Code. Accordingly, no further prosecution of the above-captioned proceeding may occur, and no valid judgment may be entered against the Debtor.
