Our firm represents Global Naps, Inc. in the above-styled matter.

This letter is written as an offer to resolve and settle the investigation relating to an apparent violation of Section 364.183(1), F.S. Upon investigation, it turns out that the request for information which the Public Service Commission sent on July 6, 2001 to Global Naps was received by the Company. Further investigation indicates that the request for information as set forth in the Commission's correspondence was apparently inadvertently misplaced. Consequently, the information was not provided to the Commission as requested. Global Naps apologizes for its unintentional failure to respond to the Commission's letter of July 6, 2001.

In order to resolve this matter in a timely and expeditious manner, Global Naps would offer to remit to the Commission payment of Three Thousand Five Hundred Dollars (\$3,500.00) within thirty (30) days of the entry of an Order accepting this Offer of Settlement'. I hope this good faith offer proves acceptable to the Commission and will allow all parties to move forward.

1As this is an offer to settle, it shall not be used as evidence in this or any other proceeding and is made to resolve a matter that would otherwise be subject to a formal hearing before the Commission.


