P.1.350, Florida Power Corporation ("FPC") serves its responses subject to the previously made general and specific objections, to the Staff of the Florida Public Service Commission's ("Staff") Fourth Request for Production and states as follows:

DOCUMENTS REQUESTED

17. Please provide the supporting documentation for the Sebring depreciation adjustment for the projected test year shown on line 25, MFR Schedule C-31, page 5, and for the prior year ended December 31, 2000, shown on page 8. (Lee)

Assuming Staff means MFR C-3a as opposed to C-31, FPC will produce documents responsive to this request.

18. Please provide all supporting documentation for the company proposed amortization of the last core of nuclear fuel and the amortization of end of life nuclear materials and supplies for the projected test year on MFR Schedule C-3, page 13, and Schedule B-4, pages 32 and 33. (Lee)

A. Amortization of last core based on actuals following the October 2001 refueling outage.

FPC's share of the fuel cost remaining in batches 12, 13, and 14 at Cycle 13 start up:

Batch 12	(5 assemblies)	356,230
Batch 13	(28 assemblies)	2,937,417
Batch 14	(72 assemblies)	20,268,645

Total = \$ 23,562,292 approximately \$24M
