Docket No. 010270-TX does not show staff assignments, however, I thought you were the appropriate person to help with this issue.

Novus Communication filed its ALEC application with the PSC on 2/28/01 and did not request confidential treatment of this filing. They are now wanting the filing to be handled as a confidential filing. Consistent with all non-confidential filings, this material has been posted on our internal CMS system and on the Internet in .PDF format. Even if this had not been done, under our old distribution procedures, copies of the filing would have been distributed to staff and made available as a public document.

RAR cannot alter a document once it is filed. We cannot determine who has already viewed and made copies of this material both within the PSC and external to the Commission. Novus has already exposed and made public this information by not requesting confidential treatment of the filing. We cannot unscramble this egg. If they were to write and request confidential treatment at this point, the Commission is assuming a big risk since we could not guarantee that the material claimed as confidential is kept from public exposure.
