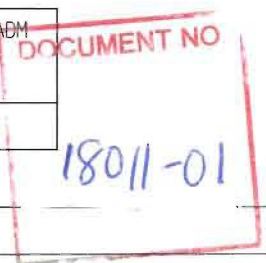

I talked to Don to see how good the data is in the RAF system. 99 data should be accurate, 98 data needs some cleanup, and 97 data does not include the whole year. That means that we should use the Joe spread sheet RAF payments prior to 99. Hopefully you can wait until Jackie and Evelyn return Jan. 2 before making a final decision.

Hi Frank. I need your help in deciding if these companies have a past due balance or not.

TC809 - 2001 Telecommunications, Inc.

Lotus shows that the company does not owe anything except a \$3.69 balance from 1991 for penalty and interest. However, the RAF System shows that they owe penalty and interest from 1995, 1996, 1997, and 1999. However, if you look at the postmark dates, it appears they should NOT owe anything. Please let me know your opinion.

TC759 - Advanced Pay Phone, Inc.

Lotus shows that the company owed \$7.50 penalty and \$1.50 interest for the 1998 payment and that is the amount of P&I they paid. Yet, the RAF System shows that the company owed \$12.50 and \$4.50 for P&I, respectively, leaving a balance of \$8.00. The company reported zero revenues for 1998 and the payment was postmarked 04/10/99. Since this was for the period 01/01 thru 12/31/98, shouldn't the due date be 02/01/99 and not 07/30/98 as the RAF system shows? I don't believe this company owes anything, but need Admin's decision. Thanks.
