Re: Approval of an Amendment to the Arbitrated Interconnection, Unbundling, Resale and Collocation Agreement Negotiated by BellSouth Telecommunications, Inc. ("BellSouth") and ICG Telecom Group, Inc. pursuant to Sections 251, 252 and 271 of the Telecommunications Act of 1996

Dear Mrs. Bayo:

Pursuant to section 252(e) of the Telecommunications Act of 1996, BellSouth and ICG Telecom Group, Inc. are submitting to the Florida Public Service Commission an amendment to their negotiated agreement for the interconnection of their networks, the unbundling of specific network elements offered by BellSouth and the resale of BellSouth's telecommunications services to ICG Telecom Group, Inc. . The initial agreement between the companies was filed in Docket 990691-TP and was deemed effective by Order No. PSC-00-1497-FOF-TP on August 18, 2000. This amendment revises Attachment 3 of the original agreement.

Pursuant to section 252(e) of the Act, the Commission is charged with approving or rejecting this amendment to the negotiated agreement between BellSouth and ICG Telecom Group, Inc. within 90 days of its submission. The Act provides that the Commission may only reject such an agreement if it finds that the agreement or any portion of the agreement discriminates against a telecommunications carrier not a party to the agreement or the implementation of the agreement or any portion of the agreement is not consistent with the public interest, convenience and necessity. Both parties agree that neither of these reasons exists as to the agreement they have negotiated and therefore, as such this amendment should be deemed effective by operation of law on April 3, 2002.

Pursuant to this Amendment, (the "Amendment"), ICG Telecom Group, Inc. ("ICG"), and BellSouth Telecommunications, Inc. ("BellSouth"), hereinafter referred to collectively as the "Parties", hereby agree to amend that certain Interconnection Agreement between the Parties dated August 18, 2000 ("Agreement").

WHEREAS, BellSouth and ICG entered into the Agreement on August 18, 2000, and;

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. The Agreement entered into between BellSouth and ICG is hereby amended to delete the following sentence from Attachment 3, Section 6.6.1: "Additionally, IP Telephony traffic will be considered switched access traffic."
2. All of the other provisions of the Agreement, dated August 18, 2000, shall remain in full force and effect.
3. Either or both of the Parties are authorized to submit this Amendment to the respective state regulatory authorities for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
