Dear Mr. Turchon:

The Division of the Commission Clerk & Administrative Services forwarded to me a copy of your 2001 Regulatory Assessment Fee (RAF) return form with the note "Out of Business" written on it. There are two kinds of cancellations. The first is voluntary, which is normally granted if the company is in good standing with the Commission and does not have a past due balance of the RAF, including statutory penalty and interest charges. The other is involuntary. If a company is <u>not</u> in good standing and has an outstanding balance of the RAF, the Commission normally cancels the certificate on its own motion for a rule violation. It should be noted that any balance owed is forwarded to the Comptroller's Office for collection.

The RAF is assessed if a certificate is active for any one day during a calendar year. The RAF is due by January 30 of each year, unless the 30th falls on a weekend, then the fee is due by the next working day, for the previous year. If payment for the RAF is mailed after the due date, then statutory penalty and interest charges are applicable.

The effective date of a voluntary cancellation is the date that the Commission received a company's request for cancellation. Therefore, I can make the effective date December 20, 2001 if payment is received by January 14, 2002. Rule 25-24.514(2), Florida Administrative Code, provides that a company requesting voluntary cancellation must either pay the 2001 RAF or provide a date certain that it will be paid.

Therefore, based on the above information, I cannot recommend a voluntary cancellation of your certificate unless the 2001 RAF is paid. Please respond in writing by January 14, 2002, and let me know how you wish to proceed. In the meantime, if you have any questions, just let me know.
