Per our telephone discussion on January 3, 2002, staff had identified several deficiencies and the need for additional information to complete the review of the application in the above referenced docket. Your January 11, 2002, supplemental filing addressed and satisfied the deficiencies. The additional information needed to complete the application is listed below.

Additional Information

1. Ms. Pamela Christmas, the manager signed the executed contract for the purchase of the utility, which is a duty that is normally performed by a corporate officer. Please submit documentation that supports Ms. Christmas's authority to act on behalf of the buyers or as a corporate officer.

2. As a result of the utility's books and records being destroyed, additional information is need in order to establish rate base at the time of transfer. Please provide a copy of Linadale Water Company's most recent Federal and state tax return.

Tariff Revisions

Listed below are a number of tariff corrections that need to be made. These corrections include but are not limited to revision levels, typos, and tariff language. For your convenience a model tariff can now be retrieved from the Florida Public Service Commission Website at <http://www.floridapsc.com>. You may find that using the tariffs from the website to be useful in correcting your tariffs for the application.

1. Tariff Sheet No. 3.0 revision level should be Sixth Revised Sheet No. 3.0, because the

transfer of Linadale will be reflected on this tariff.

2. Tariff Sheet No. 4.0 should reflect the communities served listing of Linadale Water Company (Sandy Acres) and the revision level should be "Third Revised Sheet No. 4.0".

3. Tariff Sheet No. 15.4 has a typo in the first paragraph, in the first sentence.


4. Tariff Sheet No. 15.5 has a typo in the second paragraph.

5. Tariff Sheet No. 18.3, Terms of Payment language is incorrect. The sentence needs the word "when" included within the sentence.

6. Tariff Sheet No. 16.0 doesn't reflect the correct revision level. According to the application and the tariffs on file, the correct revision level is the Fifth Revised Sheet No. 16.0.
