**XO Florida, Inc.'s Motion for Extension of Time to File Testimony**

XO Florida, Inc. (XO), pursuant to rule 28-106.204, Florida Administrative Code, files this motion for a two-week extension of time for the filing of direct and rebuttal testimony in this matter as set forth below. As grounds therefor, XO states:


1. The current schedule in this matter calls for direct testimony (all) to be filed on February 5, 2002 and rebuttal testimony (all) to be filed on March 12, 2002. XO requests that each of those two dates be extended two weeks so that direct testimony is due on February 19, 2002 and rebuttal testimony is due on March 26, 2002.

2. The requested two-week extension will be helpful as the parties continue to attempt to settle outstanding issues in this arbitration. The parties have been actively involved in negotiations as to the outstanding issues in this case. Thus far the parties have successfully settled eight open issues. Discussions are on going and the parties are hopeful that additional issues can be settled, thus obviating the need for the filing of testimony as to certain issues and narrowing the issues which will be the subject of this proceeding. A two-week extension for testimony will promote a more efficient and expeditious proceeding.

3. XO does not suggest any change in any of the other dates, including the date for the prehearing conference and hearing.

4. XO has consulted with counsel for BellSouth Telecommunications, Inc. (BellSouth) and is authorized to represent that BellSouth has no objection to the extension requested herein.

**WHEREFORE**, XO requests that the due date for rebuttal testimony be extended to February 19, 2002 and that the due date for rebuttal testimony be extended to March 26, 2002.


