RE: Request for Permission from Comptroller's Office to Write-Off the RAFs for the years 2000 and 2001 for VoCall Communications Corp. (TI677).

On June 26, 2001, Docket No. 010912-TI was established to address TI677's failure to remit RAFs for the year 2000. By Order No. PSC-01-2170-PAA-TI, issued on November 5, 2001, the Commission approved the cancellation of TI677's Interexchange Telecommunications Certificate No. 5208 due to bankruptcy. The Commission further ordered that the outstanding Regulatory Assessment Fees not be sent to the Comptroller's Office for collection, but instead, that the Division of the Commission Clerk and Administrative Services should request permission to write-off the uncollectible amount.

Therefore, staff requests that Bureau of Administrative Services/Fiscal Services Section take the appropriate steps to seek permission from the Comptroller's Office to write-off the uncollectible RAFs for the years 2000 and 2001 for TI677.
