This letter is an amendment to our settlement offer of 8/24/01 in response to correspondence and conversations with Paula J. Isler regarding a docket opened by the Florida Public Service Commission for nonpayment of the 2000 Regulatory Assessment Fee.

- 1) Docket No. 010892-TI
- 2) Enclosed is our completed Return for 2001 a check for \$50.00, representing the minimum due. (Our return for 2000 was turned in with our letter of 08/24/01.) We currently have no Florida Intrastate Revenue, but wish to keep our certificate active, as we hope to develop intrastate business in the future.
- 3) The Company has established a master calendar to track regulatory filing deadlines, and January 30th is clearly identified as the due date for the Interexchange Company Regulatory Assessment Fee Return. We will ensure that future filings are timely.
- 4) The Company agrees to waive any objection to the administrative cancellation of its certificate should it fail to pay in accordance with its settlement offer.
- 5) The Company recognizes its culpability in not submitting the filing by the required due date, and acknowledges the Commission's authority and right to impose a fine. We believe, however, that a \$500.00 fine, which might be proportionally appropriate for a large carrier, would be excessive for a small company falling under the minimum filing fee of \$50.00. Therefore, we propose a settlement of \$100.00, which represents 200% of that fee.

Thank you for your assistance and consideration. Please advise us of your decision.
