NOTICE OF WITHDRAWAL OF
OBJECTION TO SOUTH FLORIDA HOSPITAL AND HEALTHCARE
ASSOCIATION'S INTERROGATORY NOS. 60-63**

Florida Power & Light Company ("FPL") hereby files this Notice of Withdrawal of that portion of its Objections to and Requests for Clarification of South Florida Hospital and Healthcare Association's ("SFHHA") Seventh Set of Interrogatories (Nos. 60-70) and Requests for Production of Documents (Nos. 57-64) filed on February 5, 2002, concerning SFHHA Interrogatory Nos. 60-63. FPL's objection to Interrogatory Nos. 60-63 stemmed from the fact that SFHHA included Interrogatory Nos. 60-63 in both SFHHA's Sixth and Seventh Sets of Interrogatories. Subsequent to the filing of its February 5 Objections and Requests for Clarification concerning SFHHA's Seventh Set of Interrogatories, counsel for FPL received by U. S. Mail a copy of a letter from counsel for SFHHA advising that SFHHA had reissued and properly numbered its Seventh Set of Interrogatories. Accordingly, the objection raised by FPL to SFHHA Interrogatory Nos. 60-63 in its February 5 pleading is now moot and, therefore, withdrawn by FPL.

In addition, due to the renumbering of SFHHA's Seventh Set of Interrogatories, the specific objections and requests for clarification filed by FPL on February 5 concerning SFHHA's Interrogatory Nos. 66-69 would now concern SFHHA Interrogatory Nos. 70-73 as renumbered.


