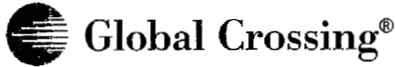

BANKRUPTCY AND AUTOMATIC STAY OF PROCEEDINGS**


PLEASE TAKE NOTICE THAT, on January 28, 2002 (the "Petition Date"), Global Crossing Telecommunications, Inc., a named Defendant in the above-captioned action ("Global Crossing"), and certain of its affiliates (collectively, the "Debtors") filed voluntary petitions for relief under Chapter 11 of the United States Bankruptcy Code, 11 U.S.C. §§ 101-1330 (the "Bankruptcy Code"), in the United States Bankruptcy Court for the Southern District of New York (the "Bankruptcy Court"). The Debtors' Chapter 11 cases are pending before the Honorable Robert E. Gerber and are being jointly administered by the Bankruptcy Court under case number 02-40188 (REG).

PLEASE TAKE FURTHER NOTICE THAT, in accordance with the automatic stay imposed by Section 362 of the Bankruptcy Code, from and after the Petition Date no cause of action arising prior to the Petition Date or relating to the period prior to the Petition Date may be commenced, continued or prosecuted against the Debtors, and no related judgment may be entered or enforced against the Debtors, outside of the Bankruptcy Court without the Bankruptcy Court first issuing an order lifting or modifying the automatic stay. Accordingly, the above-captioned action may not be prosecuted, and no valid judgment may be entered or enforced, against Global Crossing.


