NOTICE OF PROPOSED AGENCY ACTION
ORDER APPROVING TRANSFER OF OWNERSHIP

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

By letter dated November 19, 2001, Concert Communications Sales LLC (Concert Communications), British Telecommunications plc (British Telecommunications), AT&T Corp. (AT&T), and BT Group plc (BT Group) filed with this Commission an application for approval of transfer of ownership of Concert Communications from joint ultimate ownership by British Telecommunications and AT&T to sole ultimate ownership by British Telecommunications and BT Group. Concert Communications is the holder of ALEC Certificate No. 7253 and IXC Certificate No. 7372. Concert Communications has stated that it will continue to operate under its existing certificated name and tariff on file with this Commission.

In accordance with our authority under Section 364.33, Florida Statutes, to approve the acquisition or transfer of majority organizational control or controlling stock ownership of a telecommunications company providing service in Florida, we have reviewed the Petition of Concert Communications, British Telecommunications, AT&T, and BT Group, and find it appropriate to approve it. We have based our review and decision upon an analysis of the public's interest in efficient, reliable telecommunications service. We are vested with jurisdiction over this matter pursuant to Section 364.33, Florida Statutes.

Based on the foregoing, it is,


ORDERED by the Florida Public Service Commission that Concert Communications Sales LLC, British Telecommunications plc, AT&T Corp., and BT Group plc's request for approval of transfer of ownership of Concert Communications Sales LLC from British Telecommunications plc and AT&T Corp. to British Telecommunications plc and BT Group plc is hereby approved. It is further
