The Commission has received your recent correspondence with a request for cancellation of your pay telephone certificate.

Normally, the effective date of a voluntary cancellation is the date the Commission received the company's request for cancellation if the company's Regulatory Assessment Fees (RAF) are up-to-date. However, since payment for the 2001 RAF is not due until January 30, 2001, then the Commission will voluntarily cancel your certificate with an effective date of December 31, 2001 if payment is postmarked by that date (January 30, 2002) so that you will not owe the 2002 RAF.
