In reply to your letter of January 25th, 2002, we are submitting the following information in hope that we can finalize this on-going problem.

- 1. Our original certificate is enclosed.
- 2. Georgetown: Service jurisdiction was granted to this area by the Marion County Board of County Commission in June 1980. It was included with our legal descriptions for the Fore Acres area in our original Grandfather Application (see copy provided by your office). The water engineering section of the commission combined all of the legal descriptions and provided them to us to prepare tariffs. If the Georgetown area was not included, we do not feel that it was our error. Georgetown has a total of 10 homes and is completely built out. All of the residents were notified of our public hearing during our grandfather case. It has always been served by the Fore Acres plant.

In view of the above, we feel that we should not be burdened with the time-consuming notification process, much less the additional expense.

3. Libra Oaks and Waldbusser: We provided the original affidavits with our letter of September 27th, 2001. We are enclosing copies for your information.

We hope that this information will help bring this matter to completion.


