Master CMRS Interconnection Agreement

This Master CMRS Interconnection Agreement ("Agreement"), is entered into by and between NPCR, Inc. d/b/a Nextel Partners ("Nextel Partners"), a Delaware corporation, and Sprint - Florida, Incorporated, ("Sprint"), a Florida corporation, hereinafter collectively, "Parties," and individually as a "Party," is entered into this 1st day of December, 2001, for the State of Florida and is effective upon this date or the date of Commission approval, if required.

NOW THEREFORE, the parties agree as follows:

The Parties agree that the Agreement between the Parties shall consist of the CMRS Interconnection Agreement for the State of Florida entered into by and between Sprint and Nextel South Corp., amended as follows:

TERM:

This agreement shall become effective on the 1st day of December, 2001, or the date of Commission approval, if required.

RATES:

All rates provided under this agreement will include any subsequent amendments executed by Sprint and Nextel South Corp., as well as any rates based upon decisions of any federal or state court or commission having jurisdiction over this Agreement.

CONDITIONS:

All services provided under this agreement will be consistent with the decisions of courts, the Federal Communications Commission, and any state Commission having jurisdiction over this agreement, including but not limited to the decisions of the Circuit Court of Appeals and the United States Supreme Court.

This Agreement shall be amended accordingly to reflect the pricing, terms and conditions of each such Amended Rules relating to any of the provisions in this Agreement.




