Please accept this letter as an application of BAK Communications, LLC for Authority to Acquire the assets, including the customer base, of Voice Vision International, Inc. ("VVI").

BAK Communications, LLC ("BAK") is a California limited liability company. BAK was issued a Certificate of Convenience and Necessity to Provide Interexchange Telecommunications Service in Florida by Final Order issued in Docket No. 011359-TI on January 10, 2002.

VVI was issued a Certificate of Convenience and Necessity to Provide Interexchange Telecommunications Service in Florida by Final Order issued in Docket No. 990660-TI on August 30, 1999.

VVI filed for protection under Chapter 11 of the United States Bankruptcy Code. On November 6, 2001, the United States Bankruptcy Court, Central District of California, issued an Order Approving the Sale of Substantially All of VVI's Operating Assets, including its customer base, to BAK. BAK also filed with the FCC a Limited Waiver under CC Dockets No. 00-257; Implementation of the Subscriber Carrier Selection Change Provisions of the Telecommunications Act of 1996, under the FCC's new streamlined regulations.


