RE: NOTICE OF FLORIDA KEYS RATE CENTER CONSOLIDATION

By Order No. PSC-00-1937-PAA-TL, issued October 20, 2000, in Docket No. 990455-TL, the Florida Public Service Commission (PSC) approved a numbering relief plan for the Florida Keys 305 area code and ordered the implementation of Rate Center Consolidation.

The Rate Center Consolidation plan calls for consolidating seven rate centers into one rate center in the Florida Keys calling area. The Rate Centers to be consolidated are as follows:

Big Pine	Key Marathon
Islamorada	North Key Largo
Key Largo	Sugarloaf Key
Key West	

The new consolidated rate center will be called "Keys" and the Vertical & Horizontal (V&H) coordinates for this new rate center are V = 8644 and H = 0562.

Telcordia will make the necessary database changes for all carriers to reflect the implementation of the Rate Center Consolidation in the new rate center effective April 8, 2002.

The milliwatt test number is (305) 990-9999. The test number to reach a recorded announcement indicating the successful termination to the new "KEYS" rate center is (305) 990-9998.
