I'm sure there will be changes made, so perhaps by the beginning of next week we will have a complete document. The buyer also has the financial paperwork from the bank enclosed with the purchase agreement.

Questions/Clarifications:

Name Change. There will not be a name change. Water Supply, Inc. is an S Corporation as is Pinecrest Ranches, Inc. The accountant suggested that Mr. Duncan and Mr. Little buy Pinecrest Ranches, Inc. and not involve Water Supply, Inc., for tax purposes. An "S" corporation cannot hold stock in another "S" corporation. Pinecrest Ranches, Inc. will continue with the same name. However, are there any changes I need to make now that Water Supply, Inc. is out of the purchase? The purchase agreement will not reflect Water Supply, Inc., only Richard Little and Norman Duncan and partners.

Rates. Meters have not been installed at this time. Whether the purchase of Pinecrest Ranches is completed or not, meters will be installed. The buyer will install meters after the closing is complete. If the closing falls through, the seller will start installing meters within a four to six month period. Both parties our in agreement as to

the filing of the SARC application. I intend to start working on the application within the next two weeks. I will have both parties sign the application.

Closing Date. The buyer will install a contingency upon PSC approval in the purchase agreement; we hope to close immediately upon agreement of both parties.

<u>Financing.</u> The buyers have decided to finance the purchase of Pinecrest Ranches through a financial institution. The information you require will be sent along with the purchase agreement.

<u>Utility Inspection.</u> The buyer will be responsible for any repairs that are necessary, including the damaged well casing.

I intend to make the changes you have requested to the water tariff. Please let me know if there are any additional alterations to be made. \*\* mailed revised +=riff 2/18/02
