

## FPC'S AMENDED SEVENTH NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

Florida Power Corporation ("FPC" or the "Company"), pursuant to Section 366.093, *Fla. Stats.*, and Rule 25-22.006, F.A.C., files this amended seventh notice of intent to request confidential classification of FPC's Confidential Operating Report dated December 2001. In support of this Notice, FPC states as follows:

1. On or about March 1, 2002, the Staff of the Public Service Commission ("Staff") requested a copy of FPC's Confidential Operating Report dated December 2001.

2. On March 5, 2002, FPC filed a seventh notice of intent to request confidential classification of FPC's Confidential Operating Report dated December 2001.

3. With this amended Notice, FPC has delivered a complete set of the confidential documents to the Commission, with the confidential information highlighted by page or line, as appropriate. This information should be accorded confidential treatment pending the filing of FPC's Seventh Request for Confidential Classification and a decision on FPC's request by the Florida Public Service Commission.

4. As soon as practicable, but no later than twenty-one (21) days of the original Notice, FPC will file a Seventh Request for Confidential Classification specifically identifying the confidential information and explaining the basis for the request.
