Dear Ms. Vining:


As you know, I am the attorney representing IRD Osprey, LLC d/b/a Aquarina Utilities. We are attempting to finalize a transfer of the system currently owned by Service Management Systems, Inc. in the above-referenced docket. The period for protest of the Order expired on Monday, March 11, 2002 and it is my understanding that no protests have been filed to that transfer.

I also noted that on the most recent schedule for processing this case, the Final Order of the Commission scheduled to be issued by late July is listed as a "PAA Order." I believe this is an error and should be corrected, since this case includes a Notice and an opportunity for protest within 30 days of such Notice, the Order of the Commission should be issued as "Final" rather than PAA. Please let me know if there is any problem with correcting this.

The purchasing entity is desirous of moving forward as quickly as possible and is willing to do whatever is necessary to ensure that we get this transfer completed expeditiously.
