SUPPLEMENT TO APPLICATION
FOR AUTHORITY TO DISCONTINUE SERVICE

ARBROS Communications, Inc. and its subsidiaries¹ (together "ARBROS") hereby supplement their March 1, 2002 application for authority pursuant to Section 214(a) of the Communications Act of 1934, as amended (the "Act"), 47 U.S.C. § 214(a), and Section 63.71 of the Commission's Rules, 47 C.F.R. § 63.71, to discontinue the provision of domestic resold telecommunications services (the "Application").

Specifically, ARBROS submits as Exhibit A hereto the attached revised notice to its resold service customers advising them of ARBROS's planned discontinuance and of ARBROS's application to the Commission for authority to discontinue service. The revised notice is being sent to ARBROS's remaining customers of domestic resold telecommunications



EXHIBIT A – SAMPLE CUSTOMER NOTIFICATION LETTER

Re: Discontinuance of Service

Dear Customer,

As you know from our prior notice to you, ARBROS plans to discontinue providing resold domestic local exchange, toll and switched access and related services (ISDN, Internet, etc.) in your state. At present, the planned date of discontinuance is **March 16, 2002**. We have advised the Federal Communications Commission of our plan to discontinue service by March 16. We also have requested a waiver of the FCC's rules, pursuant to which a proposed discontinuance of service normally will be authorized only on the 31st day after the FCC issues a Public Notice of a request for authorization to discontinue service. We also have advised the FCC that we do not intend to discontinue service on March 16, 2002 to any remaining customer that has notified ARBROS that it has been unable to secure alternative service by that date.

We do not know if the FCC will grant the waiver request. However, due to financial difficulties the company is currently experiencing, we cannot guarantee you that ARBROS's own service providers will not discontinue service to ARBROS, and thus prevent us from continuing service to you. Therefore, we urge you to obtain an alternative service provider as promptly as possible in order to avoid any disruption of service. We will continue to work with our customers to accomplish this efficiently. Since ARBROS was a reseller of Verizon local service you should be able to contact Verizon directly and arrange for continuity of service. Please notify us once you have arranged a new service provider.

FCC rules require this notice to state:

The FCC will normally authorize this proposed discontinuance of service unless it is shown that customers would be unable to receive service or a reasonable substitute from another carrier or that the public convenience and necessity is otherwise adversely affected. If you wish to object, you should file your comments within 15 days after receipt of this notification. Address them to the Federal Communications Commission, Washington, DC 20554, referencing the Section 63.71 Application of ARBROS Communications, Inc. Comments should include specific information about the impact of this proposed discontinuance upon you or your company, including any inability to acquire reasonable substitute service.

ARBROS has been proud to be your telecommunications service provider and regrets that we will not be providing service to you in the future. We sincerely apologize

for any inconvenience this may cause you. Please do not hesitate to contact our Customer Service department at this toll free number, **888-4-ARBROS**, if we can be of assistance in your transition to a new provider. Due to a reduction in manpower you may experience a delay in reaching a representative. If that occurs, please select the option to leave a voice message, or send a fax with your contact information to (410) 865-6671, and a customer service representative will contact you within 24 hours.
