Dear Mr. Scruggs:

On March 4, 2002, the Commission received the company's 2001 Regulatory Assessment Fee (RAF) return form, along with payment for the \$50 minimum. The form had the note "cancel certificate" written on it.

Before I can recommend a voluntary cancellation, the company must be up-to-date on its RAF, including penalty and interest charges. According to Commission records, the company has a small past due penalty and interest balance in the amount of \$6 that must be paid. In addition, the company must either pay the current year's RAF or provide a date certain it will be paid (such as within 30 days from date of issuance of the Order granting the cancellation). The alternative is for the Commission to cancel the company's certificate on its own motion for violation of the RAF and cancellation rules. If that were to happen, any unpaid RAFs would be turned over to the Comptroller's Office for further collection action.
