Dear Ms. Bayó:

Pursuant to the Commission's September 24, 2001 Order Approving Settlement in the above reference docket ("Order"), OLS, Inc.'s ("OLS") submits the sixth and final installment of \$8,500.00 due towards the agreed upon voluntary payment of \$51,000

Also pursuant to the Order, OLS hereby submits the following compliance report in conjunction with this final payment:

1) OLS has fully paid the \$51,000 voluntary payment in the form of six equal monthly installments of \$8,500 submitted to the Commission on October 23, 2001, November 21, 2001, December 19, 2001, January 23, 2002, February 20, 2002 and March 21, 2002.

2) OLS has suspended all marketing in the State of Florida effective September 24, 2001, the date of the Commission's Order. OLS will not resume marketing in the state before March 25, 2002, the expiration date of the 6-month voluntary suspension. In the meantime, OLS, through undersigned counsel, has worked with Dale Buys of the Commission to create a verification transcript that is satisfactory to the Commission and in compliance with its rules.

3) OLS has settled all outstanding complaints logged against it.


