**NOTICE OF HEARINGS ON: 1) FOURTH APPLICATION OF  
MARCUS, SANTORO, KOZAK & MELVIN, P.C. FOR ALLOWANCE  
OF INTERIM COMPENSATION; 2) FINAL APPLICATION OF ROSS C. REEVES,  
EXAMINER FOR REIMBURSEMENT OF EXPENSES; AND 3) SECOND  
APPLICATION OF TROUTMAN SANDERS MAYS & VALENTINE LLP FOR  
ALLOWANCE OF INTERIM COMPENSATION**

1. Picus, Inc., Picus Communications, LLC, Sybercom, Inc., iPlus Internet Services, Inc., and Internet Enterprise Center, Inc, (collectively "Picus"), debtors-in-possession, filed the Fourth Application of Marcus, Santoro, Kozak & Melvin, P.C. ("MSKM") for Allowance of Interim Compensation (the "MSKM Application") requesting approval of fees for MSKM in the amount of \$13,323.00, and reimbursement of expenses incurred by MSKM of \$4,465.35, for a total award of \$17, 788.35, for the period of October 30, 2001 through March 6, 2002. The Application also reflects the sources from which Picus desires to compensate and reimburse MSKM.

2. Incorporated into the MSKM Application was a Final Application of Ross C. Reeves, Examiner ("Reeves") for Reimbursement of Expenses (the "Reeves Application") requesting approval for reimbursement of expenses incurred by Reeves of \$5,803.43. The Application also reflects the sources from which Picus desires to reimburse Reeves.

3. Troutman Sanders Mays & Valentine LLP ("TSMV"), counsel for the Official Unsecured Creditors Committee, filed its Second Application for Allowance of Interim Compensation (the "TSMV Application") requesting approval of fees for TSMV in the amount of \$34,416.00 and reimbursement of expenses incurred by TSMV of \$1,210.50, for a total award of \$35,626.50, for the period March 1, 2001 through February 28, 2002. The Application also reflects the sources from which Picus desires to compensate and reimburse TSMV.
