CITIZENS' RESPONSE TO TALK AMERICA'S MOTION FOR SUMMARY FINAL ORDER AND MOTION TO DISMISS

The Citizens of Florida (Citizens), by and through Jack Shreve, Public Counsel, file this response to the motion for summary final order and motion to dismiss filed by Talk America on March 19, 2002.

Citizens support and adopt the response to these motions filed by staff. In addition, Citizens once again urge the Commission to hold public hearings in this case.¹ Hundreds upon hundreds of customers have contacted the Florida Public Service Commission with complaints about Talk America. If the Commission were to hold public hearings in the major metropolitan areas of the state, each of the customers could be notified about the hearing and invited to attend. This would be an economical and efficient way for the Commission to hear from the public concerning Talk America and take direct evidence in the case. Since Talk America has now filed specific responses to the complaints, these responses should be forwarded to the individual customers with an invitation for
