
Dear Ms. Bayo:

**TAMPA ELECTRIC COMPANY'S REPORT ON STATUS
OF TERRITORIAL AGREEMENT BETWEEN TAMPA ELECTRIC
COMPANY AND WITHLACOOCHEE RIVER ELECTRIC COOPERATIVE, INC.**


Pursuant to Article IV, Section 4.1 of the Territorial Agreement between Withlacoochee River Electric Cooperative ("WREC") and Tampa Electric Company ("Tampa Electric"), as approved in Order No. 23905 issued in Docket No. 900752-EU on December 26, 1990, this filing will serve as Tampa Electric's report on the status of such agreement.

This is to advise the Commission that the subject territorial agreement remains in full force and effect and that no modifications have been proposed in such agreement nor have the parties encountered any disputes concerning the provisions of such agreement. The parties have determined that they need to transfer service to a small number of customers (some from Tampa Electric to WREC and some from WREC to Tampa Electric) in order to fully comply with the territorial agreement. Accordingly, the parties have filed a joint petition with the Commission seeking approval of such transfers.

The parties will advise the Commission to the extent that any changes are proposed and will petition the Commission to resolve any disputes which may arise concerning the provisions of the agreement which the parties are unable to resolve.


