Please accept this letter as formal notification that BroadStreet Communications, Inc. ("BroadStreet") hereby intends to cease operations nationwide effective December 7, 2001.

BroadStreet is currently a certificated provider of local exchange, resale long distance and data services in the State of Florida. Although certificated, BroadStreet does not currently operate any facilities in the State of Florida. While in those states in which BroadStreet currently operates an effort is being made by the remaining skeleton staff to transition customers in an effort to receive the requisite regulatory approval, no customers need to be transitioned in Florida.

Accordingly, we are assuming that no other action need be taken except to request the Commission withdraw and/or cancel all certificates for BroadStreet within the state.
