On August 8, the Commission received your letter dated August 2, 2001, requesting cancellation of Vision's ALEC certificate. Commission records show that Vision has two certificates with the Commission, the ALEC and an IXC certificate. Please confirm in writing that Vision wishes to cancel only the ALEC certificate. Or, in the alternate, please advise if you wish both certificates to be cancelled.

Enclosed are copies of Rules 25-24.474 and 25-24.820, Florida Administrative Code, which deals with cancellation of certificates. Your August 2nd letter included only the reason why you are requesting cancellation. Before staff can recommend a voluntary cancellation, a company must provide all information required in the rules, including either paying the current year's Regulatory Assessment Fee (RAF) or providing a date certain it will be paid.

If you need the 2001 RAF return forms, please let me know and I will fax one or both to you. As soon as the information/payment for the 2001 RAF is received, a docket will be established to voluntarily cancel Vision's certificate(s).

25-24.474 Cancellation of a Certificate.

(1) The Commission may on its own motion cancel a company's certificate for any of the following reasons:

- (a) Violation of the terms and conditions under which the authority was originally granted;
- (b) Violation of Commission rule or order; or
- (c) Violation of Florida Statutes.

(2) If a certificated company desires to cancel its certificate, it shall request cancellation from the Commission in writing and shall provide the following with its request.

- (a) Statement of intent and date to pay Regulatory Assessment Fee.
- (b) Statement of why the certificate is proposed to be cancelled.
- (c) A statement on treatment of customer deposits and final bills.
- (d) Proof of individual customer notice regarding discontinuance of service.

(3) Cancellation of a certificate shall be ordered subject to the holder providing the information required by subsection (2).

25-24.820 Revocation of a Certificate.

(1) The Commission may on its own motion, after notice and opportunity for hearing, revoke a company's certificate for any of the following reasons:

- (a) Violation of a term or condition under which the authority was originally granted;
- (b) Violation of Commission rule or order;
- (c) Violation of Florida Statute; or
- (d) Violation of a price list standard.

(2) If a certificated company desires to cancel its certificate, it shall request cancellation from the Commission in writing and shall provide the following with its request. Cancellation of a certificate shall be ordered subject to the holder providing the required information.

- (a) A statement of intent and date certain to pay regulatory assessment fee.
- (b) A statement of why the certificate is proposed to be canceled.
- (c) A statement as to how customer deposits and final bills will be handled.
- (d) Proof of individual customer notice regarding discontinuance of service.
