Dear Ms. Kelly:

On October 4, 2001, the Commission received your September 28^{th} letter, along with a copy of your August 27^{th} letter requesting cancellation of the company's certificate. There are two kinds of cancellations. The first is voluntary, which is normally granted if the company is in good standing with the Commission and complies with Rule 25-24.474, Florida Administrative Code. The other is involuntary. If a company is <u>not</u> in good standing and does not comply with the above rule, the Commission normally cancels the certificate on its own motion for a rule violation. Rule 25-24.474(2) and (3), F.A.C., states:

- (2) If a certificated company desires to cancel its certificate, it shall request cancellation from the Commission in writing and shall provide the following with its request:
- (a) Statement of intent and date to pay Regulatory Assessment Fee.
- (b) Statement of why the certificate is proposed to be cancelled.
- (c) A statement on treatment of customer deposits and final bills.
- (d) Proof of individual customer notice regarding discontinuance of service.
- (3) Cancellation of a certificate shall be ordered subject to the holder providing the information required by subsection (2).

The effective date of a voluntary cancellation is the date that the Commission received a company's request for cancellation. In this case, the Commission did not receive your request until October 4, 2001, therefore, the company will owe the 2001 Regulatory Assessment Fee (RAF), even though your letter stated you had no customers in Florida. This means that the company must either pay the 2001 RAF or provide a date certain that it will be paid, such as within 30 days after the Commission Order is issued granting the voluntary cancellation. If you need me to fax you the 2001 RAF return form, please let me know.


