CASE BACKGROUND

The above docket was initiated pursuant to a Pay Telephone Service Provider Regulatory Assessment Fee Return which had "Out of Service" written on it. A subsequent letter dated January 17, 2002, informed the owner that a voluntary cancellation docket was being opened to cancel the certificate. No response was received, and staff proceeded with the voluntary cancellation.

By Order No. PSC-02-0285-FOF-TC, issued March 5, 2002, Certificate No. 7960 issued to Townsite Corporation was cancelled.

On March 21, 2002, staff was notified by Mr. Gonzalez with Townsite Corporation that it was not Townsite's intention to have Certificate No. 7960 cancelled. Therefore, staff is requesting that Order No. PSC-02-0285-FOF-TC, issued March 5, 2002, be vacated.

### **DISCUSSION OF ISSUES**

**ISSUE 1:** Should Order No. PSC-02-0285-FOF-TC, issued March 5, 2002, in Docket No. 020135-TC be vacated?

**RECOMMENDATION:** Yes. (Williams)

**STAFF ANALYSIS:** Since Townsite Corporation did not want Certificate No. 7960 to be cancelled, staff is recommending that Order No. PSC-02-0285-FOF-TC, issued March 5, 2002, be vacated.

**ISSUE 2:** Should this docket be closed?

**RECOMMENDATION:** Yes, this docket should be closed upon issuance of the Commission's vacating order. (Dodson)

**STAFF ANALYSIS:** This docket should be closed when the Commission's order is issued vacating its approval of the cancellation of the certificate.
