1. The Intervenors hereby join in support of Tampa Electric Company's Request for Return of Confidential Documents Or, In the Alternative, For An Extension Of The Confidential Protection Afforded Such Documents By The Commission, filed on or about April 15, 2002, and, by this reference, incorporate said Request in Intervenors' instant Request.
2. Consistent therewith, the Intervenors specifically request the return of Bates Stamp 1266-0, to the extent such document shows "numerical values referring to annual sales and gallons delivered in the first paragraph"; and Bates Stamp 1318-0, 1319-0, and 1320-0, to the extent such documents show "numbers representing monetary values and paragraph titled 'Financial Data,'" all as set forth in Order No. PSC-00-1886-CFO-EI (October 16, 2000), and as amplified regarding 1318-0 and 1319-0 in Order No. PSC-00-2537-PCO-EI (December 29, 2000).
3. Consistent therewith, the Intervenors request renewed confidential classification for the portions of the prefiled direct testimony of Stephen W. Sidelko and Exhibit SWS-1, the CSA between Tampa Electric Company and Intervenor Odyssey Manufacturing Company which were granted confidential classification by Order No. PSC-00-1896-CFO-EI (October 17, 2000).

WHEREFORE, Intervenors request that the Commission take such action and issue such orders as may be necessary to authorize the return or renewed confidential classification of the documents described in the body of Intervenors' instant Request.
