Dear Mr. Ileri:

This letter is to inform you of the status of the discussions between AT&T and BellSouth regarding AT&T's complaint against BellSouth for blocking calls to Oddball Codes and for BellSouth's refusal to port telephone numbers assigned from Oddball Codes. BellSouth's letter of March 12, 2002, indicated that BellSouth had progress toward resolving certain issues raised in the complaint. However, several questions are still pending final response.


In its letter of March 12, 2002, BellSouth stated that it had completed implementation of its routing method for routing calls to the 930 Oddball Code in those LATAs where BellSouth has Uniserve customers. This point in the letter raises the question as to whether BellSouth has implemented or will implement the same routing method in those LATAs that currently do not have a Uniserve Customer but could have such a customer in the future. Bear in mind that Uniserve is a tariffed service and available for sale in all of BellSouth's LATAs. The service has not been grandfathered and there remains the potential that it could be sold to a new customer in a LATA that currently does not have a Uniserve customer and in which the routing method has not been implemented. If this happens, we would be right back where we are now.

BellSouth's letter also indicated that it is working to transition its current customers from services using the other Oddball Codes (203, 204, 440, and 780). In addition to the 930 Code, AT&T has also experienced blocking problems with AT&T customers seeking to call telephone numbers from the 780 Oddball Code. BellSouth has not indicated whether it has or will implement a routing method that will enable these calls to complete.

I have discussed the questions noted above with BellSouth and they indicated that they would seek to respond but I have not yet received a response. If you have any questions, please call me at (850) 425-5209.
