Easton Telecom Services, Inc. ("Easton") is currently authorized to provide alternative local exchange telecommunications service (ALEC) and interexchange telecommunications services in the State of Florida pursuant to Certificate Nos. 3989 and 5187 granted by the Commission in its Orders dated July 3, 1997 and April 7, 1995, respectively.

Pursuant to an order entered by the United States Bankruptcy Court for the Southern District of New York on November 15, 2001, in Chapter 11 Case No. 01-12974 (SMB), certain of Easton's assets, including Easton's Florida customer base, were sold to and were assumed by Weston Telecommunications, LLC as of November 16, 2001.

Accordingly, because Easton is no longer an operational provider of any services to Florida customers pursuant to the above-referenced certificate, it hereby requests cancellation thereof. Similarly, because Easton had ceased all telecommunications operations in Florida prior to year-end 2001 and will not be an operational entity going forward, it has not filed an annual report for that year.



DECLARATION OF ALESSANDRA DAIGNEAULT


