1	Q. Please state your name and address.
2	A. My name is Sharon R. Warren. My business address is 390 North Orange
3	Avenue, Suite 2000, Orlando, Florida, 32801.
4	Q. Who do you work for?
5	A. I am Assistant Manager of Network Auditing for Florida Digital
6	Network, Inc. ("FDN").
7	Q. What are your responsibilities as Assistant Manager of Network
8	Auditing for FDN?
9	A. I am responsible for monitoring and managing FDN's network costs.
10	Specifically, I insure that appropriate network elements and
11	telecommunications services are ordered, and I review and audit carrier-to-
12	carrier billings. As part of my responsibilities, I am also responsible for
13	making recommendations and performing analyses of overall network
14	architecture, network efficiency and cost savings.
15	Q. Please describe your work experience in the telecommunications
16	sector.
17	A. I have over 14 years experience in the telecommunications field,
18	specifically in the operations/network cost arena. Since joining FDN in
19	January 1999 I have held several positions: Supervisor of Network
20	Provisioning, Implementation Group Team Member, and, currently, Assistant
21	Manager of Network Audit. While working in Network Provisioning, I was
22	responsible for the installation and maintenance of the entire network
23	infrastructure, including switched access trunk arrangements to all ILECs,

1	internal trunking to all collocation sites, and all backbone network to
2	integrate the switches. As part of the Implementation group, I was
3	responsible for managing the collocation process from start to finish. This
4	involved tracking the applications through the ILEC system, coordinating
5	with both internal and external departments in the installation and turn-up of
6	all equipment.
7	Prior to joining FDN, I worked for 9 1/2 yrs for American Network
8	Exchange (AMNEX), an IXC/OSP with annual revenues of \$150 million.
9	The last position I held at AMNEX was Director of Network Engineering. In
10	this position I held overall management responsibility for the entire network
11	in 32 states and Mexico. My main duties included managing the design,
12	installation and maintenance of a national network for three switching
13	facilities and live/auto operator center. I was also responsible for all vendor
