


1. On August 30, 2000, the Commission issued and Order granting Bellsouth's Requests for Confidential Treatment of Document No. 03025-98.
2. The reasons BellSouth asserted in support of confidential treatment in its original Requests for Confidential Treatment continue to pertain. Specifically, there is still a need to protect customer specific-proprietary business information and information which is not subject to public disclosure.

3. The information requested remains in the possession of the Commission Staff.

4. For the reasons set forth above, and in BellSouth's original Requests for Confidential Classification, BellSouth hereby requests that the Commission enter an order extending the period of confidential classification for an additional 18 months, or for any longer period of time that the documents remain within the possession of Staff.
