RE: Request for Permission from Comptroller's Office to Write-Off the RAFs for the years 2001 and 2002 for Net2000 Communications Services, Inc. (TJ068 and TX463).

On January 22, 2002, Docket No. 020048-TP was established to address Net2000 Communications Services, Inc.'s cancellation of Interexchange Telecommunications (IXC) Certificate No. 5611 and Alternative Local Exchange Telecommunications (ALEC) Certificate No. 7528 due to bankruptcy. By Order No. PSC-02-0447-PAA-TP, issued on April 3, 2002, the Commission approved the cancellation of Net2000 Communications Services, Inc.'s IXC Certificate No. 5611 and ALEC Certificate No. 7528. The Commission further ordered that the outstanding Regulatory Assessment Fees not be sent to the Comptroller's Office for collection, but instead, that the Division of the Commission Clerk and Administrative Services should request permission to write-off the uncollectible amount.

Therefore, staff requests that Bureau of Administrative Services/Fiscal Services Section take the appropriate steps to seek permission from the Comptroller's Office to write-off the uncollectible RAFs for the years 2001 and 2002 for TJ068 and TX463.
