In the year 2000, the Commission had the above cancellation docket established for nonpayment of the 1999 Regulatory Assessment Fee (RAF). Staff was subsequently notified that Crescent had filed for Chapter 11 bankruptcy protection, Case No. 99 B 10183(AJG). We also received a letter dated October 13, 2000 from Melissa A. Hager of Rosenman & Colin LLP asking the Commission to withdraw any action due to the bankruptcy proceedings.

We have now received an application from Crescent Telephone Company, Inc. for a pay telephone certificate. In researching the name, Commission staff discovered that Crescent Telephone had purchased Crescent Public Communications' assets out of bankruptcy and found that Crescent Public Communications' pay telephone certificate is still active.

Please advise if Crescent Public Communications, Inc. (1) is still in bankruptcy; (2) still exists; and (3) wishes to keep its certificate active with the Florida Public Service Commission.

If the company wishes to cancel its certificate, please write the Commission a letter and request cancellation due to the bankruptcy (or because the company is no longer in business).
