XO FLORIDA, INC.'S REQUEST FOR SPECIFIED CONFIDENTIAL CLASSIFICATION AND MOTION FOR PROTECTIVE ORDER FOR EXHIBIT NO. (RK-4) TO THE TESTIMONY OF REX KNOWLES

XO Florida, Inc. (XO), pursuant to Rule 25-22.006, Florida Administrative Code, files this Request for Specified Confidential Classification and Motion for Protective Order for Exhibit No. _____ (RK-4) to the Testimony of Rex Knowles.

- 1. On April 16, 2002, XO filed the supplemental testimony and exhibit of Rex Knowles of XO. On the same day, XO filed its Notice of Intent to Request Specified Confidential Classification for Exhibit No. _____ (RK-4) to the testimony of Rex Knowles of XO.
- 2. The confidential portions of the exhibit to Mr. Knowles' testimony contain information specifically related to XO's business operations. XO considers this information to be confidential, proprietary business information. The confidential information is related to XO's switch and XO's ability to serve customers in certain geographic areas. Disclosure of the information would harm XO's competitive business interests. The information has not been made public and is governed by a Protective Agreement between the parties. A more specific description of this information is contained in Attachment A.
- 3. Section 364.183, Florida Statutes, provides an exemption from the disclosure requirements of section 119.07, Florida Statutes, when disclosure of confidential business information would "impair the competitive business of the provider of the information." Disclosure of the XO confidential information would harm its business operations by placing details of its operations and capabilities in the public domain. Accordingly, the information should be exempt from the public disclosure requirements of section 119.07, Florida Statutes.
