Dear Mr. Little:

The Commission received your letter dated April 26, 2002, requesting cancellation of your pay telephone certificate. As information, the Regulatory Assessment Fee (RAF) is applicable if a certificate is active for any one day during a calendar year, even if a company was not operating or had any revenues during that period. A copy of the 2002 RAF return form is enclosed in case you want to go ahead and send in the minimum \$50 RAF.

The alternative to a voluntary cancellation is an involuntary cancellation. The difference between the two types of cancellations is that if the Commission cancels your certificate involuntarily, any unpaid RAFs will be turned over to collections. Therefore, before I can recommend a voluntary cancellation, the company needs to comply with Rule 25-24.514(2), Florida Administrative Code, which provides that a company must either pay the current year's RAF, in this case for calendar year 2002, or provide a date certain it will be paid.
