

**RE:** Request for Permission from Comptroller's Office to Write-Off the RAFs for the years 2000 and 2001 for BroadStream Corporation (TJ236 and TX294).

On January 30, 2002, Docket No. 020083-TP was established to address BroadStream Corporation's cancellation of Interexchange Telecommunications (IXC) Certificate No. 7088 and Alternative Local Exchange Telecommunications (ALEC) Certificate No. 7089 due to bankruptcy. By Order No. PSC-02-0542-PAA-TP, issued on April 18, 2002, the Commission approved the cancellation of BroadStream Corporation's IXC Certificate No. 7088 and ALEC Certificate No. 7089. The Commission further ordered that the outstanding Regulatory Assessment Fees not be sent to the Comptroller's Office for collection, but instead, that the Division of the Commission Clerk and Administrative Services should request permission to write-off the uncollectible amount.

Therefore, staff requests that Bureau of Administrative Services/Fiscal Services Section take the appropriate steps to seek permission from the Comptroller's Office to write-off the uncollectible RAFs for the years 2000 and 2001 for TJ236 and TX294.
