BellSouth Telecommunications, Inc. ("BellSouth") hereby files, pursuant to Rule 25-22.006, Florida Administrative Code, this Request For Specified Confidential Classification and states the following:

1. In a letter dated March 29, 2002, the Florida Public Service Commission (the "Commission"), requested that BellSouth provide information concerning the service provided to Touch-Map Systems located at 8288 Business Park Drive in Port St. Lucie. Specifically, the Commission requested copies of all service orders and trouble tickets associated with certain telephone numbers for the period of January 1, 2002 through March 31, 2002. This information is being provided in connection with the Commission's request.

2. Pursuant to Rule 25-22.06(3)(a), BellSouth is now filing a Request for Confidential Classification for these documents because they contain customer specific information, as well as confidential and proprietary business information that is considered confidential and proprietary to Touch-Map Systems and BellSouth. A more specific description of this information is contained in Attachment A.

3. BellSouth has treated and intends to continue to treat the information for which confidential classification is sought as private, and this information has not been generally disclosed.


4. Appended hereto as Attachment B are two copies of the requested documents with the confidential information deleted.
