Joint Letter Application of Teligent Services, Inc. and TAC License Corporation for Approval to Consummate a Transaction Arising Out of Chapter 11

Dear Ms. Bayo:

On or about September 6, 2001, Teligent Services, Inc. ("Teligent "or "TSI") together with TAC License Corporation ("TAC" or "New Teligent") filed a Petition describing their plans, at that time, to enter into a transaction that, *if consummated*, would enable TSI's assets and operations to be purchased out of Chapter 11¹ by a newly-formed entity, TAC created solely for this purpose ("TAC Transaction Re-emergence Plan"). On December 13, 2001, wherein the Commission granted its consent to the transfer/assignment of TSI's assets and certificates to TAC. A Consummation order was issued *See* Order No. PSC-01-2154-PAA-TP. A portion of this Order was vacated at Teligent's request, however, effective March 14, 2002, because the TAC transaction had not yet been consummated. *See* Order No. PSC-02-0344-FOF-TP.

The TAC Transaction Re-Emergence Plan, as initially explained to the Commission, was subject, among other things, to the following three conditions precedent: the completion of necessary financing (to both bring the assets and operations out of bankruptcy and to fund on-going operations thereafter); the conclusion of a Chapter 11 bankruptcy auction whereby other bidders could bid to purchase the assets; and the issuance of a Sale Order to TAC. None of these three conditions were satisfied and the TAC Transaction was not able to close.²

The Commission approved this application pursuant to Notice of Proposed Agency Action: Order Approving Assignment of Florida Operations and Assets, Assignment of and Name Change on Alternative Local Exchange Telecommunications Certificate, Interexchange Telecommunications Certificate and Alternative Access Vendor Certificate. Docket No. 011-286-TP, Order PSC-01-2154-PAA-TP, issued November 5, 2001 and Consummating Order, Docket No. 011-286-TP, Order No. PSC-01-2437-CO-TP, issued December 13, 2002. Effective March 14, 2002, at TSI's request, the Commission vacated Order No. 01-254-PAA-TP and Consummation Order PSC-01-2437-CO-TP in Docket No. 11286-TP because the transaction had not yet closed. See Order No. PSC-02-0344-FOF-TP

A Chapter 11 bankruptcy auction was held on October 29, 2001, but no bids for the Teligent assets or operations were received at that time.

Unfortunately, due to the events that occurred in the United States on September 11, 2001, and shortly thereafter, and their severe impact on the financial markets, which were already in a volatile state, TAC was unable to complete the financing necessary to consummate the TAC Transaction Re-emergence Plan, as initially contemplated, by the early December 2001 deadline. Nevertheless, Teligent continued to diligently work with potential investors to enable some type of a Re-emergence Plan, potentially through the TAC legal entity, to occur.

Recently, after several months of continuing to work with its senior secured lender group and to develop an alternative plan to the original TAC Transaction that would enable Teligent to emerge from bankruptcy in some form, Teligent was able to develop a Plan of Reorganization ("POR") that will enable TSI to emerge *as a going concern*, in tact, as the same corporate entity initially certificated by this Commission. TSI has, this same day, submitted correspondence to the Commission describing its POR and asking for any necessary consent thereto.³

As a result, it is no longer necessary that TAC becomes certified to provide service through the transfer or assignment of TSI's existing certificates. See attached sworn verification from TAC's sole officer, Richard Hozik, confirming this fact. Consequently, Teligent and TAC respectfully request that the Commission vacate, cancel or otherwise rescind, without prejudice, to the extent necessary, the consent it previously granted to TSI to consummate the Re-emergence Plan through the TAC Transaction and to transfer its certificates to TAC.
