1. On May 14, 2002, BellSouth filed its Complaint Regarding the Practices of WorldCom, Inc. in the Reporting of Percent Interstate Usage for Compensation for Jurisdictional Access Services, along with a Notice of Intent to Request Specified Confidential Classification. Portions of BellSouth's Complaint contain information that is considered confidential and proprietary to WorldCom.

2. Pursuant to Rule 25-22.06(3)(a), BellSouth is now filing a Request for Confidential Classification for portions of its Complaint because this information contains customer-specific confidential business information that may be considered confidential and proprietary to WorldCom.
