Notice to Customers of Approval of Impact Fee  
Dated May 13, 2002

Dear Customer:

By Order No. PSC-02-0648-TRF-WU issued May 13, 2002 in Docket No. 020247-WU, the Florida Public Service Commission granted Venture Associates Utilities Corporation an increase for the City of Ocala Impact Fee. In April 2001, the City of Ocala increased its impact fee to vary by the square footage of the single-family residence. Venture Associates Utilities filed an application to change its tariff to reflect the current fees.

By Order No. PSC-96-0790-FOF-WU, on June 18, 1996, Venture Associates Utilities was initially authorized to include the City's impact fee within its tariff. The rates listed below reflect the City of Ocala's current rate schedule for impact fees and if there is no timely protest by a substantially affected person to the order dated May 13, 2002, the rates will become effective for service rendered on or after June 07, 2002.

Residential-per ERU	0-1,499 sq. ft. for \$	503.00
Residential-per ERU	1,500-2,499 sq. ft. for \$	629.00
Residential-per ERU	2,500-3,499 sq. ft. for \$	838.00
Residential-per ERU	3,500 sq. ft. for	\$1,048.00


