**PUBLIX SUPER MARKETS, INC.'S NOTICE OF
WITHDRAWAL AS A PARTY**

Publix Super Markets, Inc. ("Publix") , by and through its undersigned counsel, hereby provide notice of its withdrawal as a party in this Docket No. 010233-EI (the "RTO Docket"), effective as of the date of this Notice, and in support thereof states as follows:

1. By Order No. PSC-01-2198-PCO-EI dated November 13, 2001, Publix's petition to intervene in Docket No. 000824-EI, In re: Review of Florida Power Corporation's earnings, including effects of proposed acquisition of Florida Power Corporation by Carolina Power & Light (the "FPC Docket") was granted by the Florida Public Service Commission (the "Commission").
2. By Order No. PSC-01-2429-PCO-EI dated December 12, 2001, Publix's petition to intervene in Docket No. 001148-EI, In re: Review of the retail rates of Florida Power & Light Company (the "FPL Docket") was granted by the Commission.
3. The FPL Docket, FPC Docket and Docket No. 010577 (the "TECO Docket") had a combined first phase ("Phase I") dealing with the formation of a proposed regional transmission organization ("RTO"). At the conclusion of hearings on Phase I, the Commission determined that a separate docket should be established to address a revised proposal for the organization of a non-profit RTO ordered by the Commission to be filed by Florida Power Corporation, Florida Power & Light Company and Tampa Electric Company (the "GridFlorida Companies")



On March 13, 2002, the Commission Office of General Counsel issued a Memorandum to all Parties of Record in the FPC Docket, the FPL Docket and the TECO Docket indicating that the RTO Docket had been established. The Memorandum stated further that all parties of record in the FPC Docket, the FPL Docket and the TECO Docket would automatically be made parties to the new RTO Docket.
5. As a party in both the FPC Docket and the FPL Docket, Publix was made a party to the RTO Docket.
6. Publix has not actively participated in the RTO Docket to date and does not currently anticipate doing so.

Publix therefore files this Notice of Withdrawal as a party in the RTO Docket and requests that no further testimony, pleadings, exhibits or other documents filed in this RTO Docket be provided to Publix.
