Dynegy CLEC Communications, Inc. respectfully requests that ALEC Certificate Number 7838 be changed to reflect the following name:



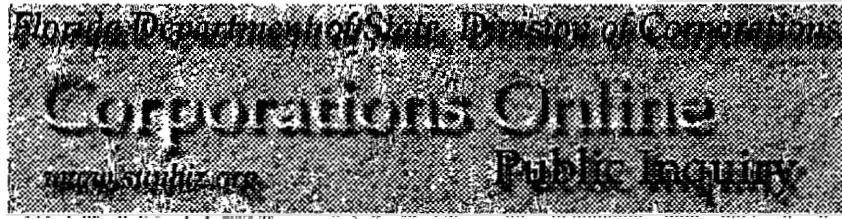
