1. On October 23, 2001, the Commission issued Order No. PSC-01-2107-SC-TP ordering that Talk America, Inc. (Talk America) show cause in writing within 21 days why it should not be fined for its apparent violations of Section 364.604(2), Florida Statutes, and Rules 25-4.118 and 25-22.32(5)(a), Florida Administrative Code. and Extension of Time to Respond to the Order and on November 6, 2001, Talk America filed a request for a hearing. By Order No. PSC-02-0095-PCO-TP, issued January 16, 2002, Talk America's request for an extension of time to file a response to the Show Cause Order was granted.

- 2. On March 19, 2002, Talk America filed its initial response and renewed its request for hearing. Talk America also filed its Motion for Summary Final Order and Motion to Dismiss on March 19, 2002.
- 3. On March 26, 2002, staff filed its Responses to Talk America's Motion to Dismiss and Motion for Summary Final Order. Also, on March 26, 2002, the Office of Public Counsel (OPC) filed its Response to Talk America's Motions to Dismiss and Motion for Summary Final Order. Included in OPC's response was a request for public hearings to be held in this matter. Staff filed its response to OPC's request on April 1, 2002. On June 4, 2002, Talk America filed its response to OPC's request for public hearings.
- 4. By Order No. PSC-02-0733-PCO-TP, issued May 30, 2002 (Order Establishing Procedure), the hearing dates, the prehearing date, and key activities dates were established. Currently, the

Hearing is scheduled for September 18 and 19, 2002, and the Prehearing is scheduled for September 4, 2002.

- 5. On June 11, 2002, Talk America file its Offer Of Settlement and another Motion for Summary Final Order.
- 6. Due to the recent settlement offer filed by Talk America, staff requests that the hearing, prehearing and key activities dates be suspended. Suspending the key activities dates, along with the hearing and prehearing dates, would allow the parties to focus their resources on settlement discussions.
- 7. Should Talk America's Settlement Offer be rejected by the Commission, staff further requests that the hearing, prehearing and key activities dates, remain suspended until such time as the Commission addresses Talk America's outstanding Motions for Summary Final Order, Motion to Dismiss, and OPC's request for public hearings. Since these motions and OPC's request for public hearing have direct impact on the processing of this case, it would be in the interest of judicial economy to resolve them prior to reestablishing a hearing schedule.
- 8. Staff counsel has contacted counsels for Talk America and OPC and both counsels represented that they support the Motion.
